MINUTES OF THE 130th MEETING OF THE CONVENTION CENTER AUTHORITY OF THE METROPOLITAN GOVERNMENT OF NASHVILLE & DAVIDSON COUNTY

The 130th meeting of the Convention Center Authority of the Metropolitan Government of Nashville and Davidson County (CCA) was held on September 5, 2024 at 9:00 a.m. in the Administrative Conference Room of the Administrative Offices at the Music City Center, Nashville, Tennessee.

AUTHORITY MEMBERS PRESENT: Norah Buikstra, Alfred Degrafinreid II, Tracy Hardin, Tre Hargett, Barrett Hobbs, Vonda McDaniel, Rachel Offutt (Designee for David Lillard), Jennifer Pfeiffer (Designee for Jason Mumpower), Dee Patel, Seema Prasad, and Betsy Wills

AUTHORITY MEMBERS NOT PRESENT: Robert Davidson

OTHERS PRESENT: Charles Starks, Charles Robert Bone, Jasmine Quattlebaum Kelli Donahoe, Donna Gray, Brian Ivey, Heather Jensen, Heidi Runion, Chris Mustain, Robin Rieek, and Hadley Hitson

Chair Norah Buikstra opened the meeting for business at 9:04 a.m. and stated that a quorum was present.

ACTION: Appeal of Decisions from the Convention Center Authority of the Metropolitan Government of Nashville and Davidson County – Pursuant to the provisions of § 2.68.030 of the Metropolitan Code of Laws, please take notice that decisions of the Convention Center Authority may be appealed if and to the extent applicable to the Chancery Court of Davidson County for review under a common law writ of certiorari. These appeals must be filed within sixty days after entry of a final decision by the Authority. Any person or other entity considering an appeal should consult with private legal counsel to ensure that any such appeals are timely and that all procedural requirements are met.

Chair Norah Buikstra read the Mission Statement of the Music City Center (Attachment #1), and there was discussion.

There were no public comment requests received for this meeting (Attachment #1).

ACTION: Vonda McDaniel made a motion to approve the 129th Meeting Minutes of July 11, 2024. The motion was seconded by Alfred Degrafinreid II and approved unanimously by the Authority.

The next regularly scheduled meeting is scheduled for Thursday, October 3, 2024 at 9:00 a.m.

Charles Starks provided an Operations update, and there was discussion.

Chair Norah Buikstra, Charles Starks, and Jasmine Quattlebaum provided information on the RFP Feasibility Study to determine need for the Music City Center Expansion (Attachments #1 and #2), and there was discussion.

Charles Starks noted that the Feasibility Study is the first phase of any potential future expansion. The study will look at demand, demographics, projected future business, and the hotel market, among other business impacts. It will also include insights on lost business and feedback from past, current, and future customers. Charles Starks affirmed that Music City Center would be involved throughout the study process to determine if additional data should be collected. Chair Norah Buikstra acknowledged more studies may be needed.

ACTION: Tracy Hardin made a motion [i] accepting the recommendation of the evaluation committee and [ii] authorizing Charles Starks to negotiate and execute an agreement with HVS Convention, Sports and Entertainment Facilities Consulting to provide a feasibility study to determine the need for potential expansion of the Music City Center, on substantially the same terms as considered this day. The motion was seconded by Dee Patel and approved unanimously by the Authority.

Charles Starks and Jasmine Quattlebaum provided information on the RFP Elevator/Escalator Maintenance Services (Attachments #1 and #3), and there was discussion.

ACTION: Vonda McDaniel made a motion accepting [i] accepting the recommendation of the evaluation committee and [ii] authorizing Charles Starks to negotiate and execute an agreement with TK Elevator Company to provide elevator and escalator maintenance services, on substantially the same terms as considered this day. The motion was seconded by Alfred Degrafinreid II and approved unanimously by the Authority.

Charles Starks and Jasmine Quattlebaum provided information on the Contract Extension Audio Visual (Attachments #1 and #4), and there was discussion.

ACTION: Alfred Degrafinreid II made a motion authorizing Charles Starks to negotiate and execute an amendment to the audio-visual services agreement with LMG, LLC exercising the option to extend the agreement for an additional two years until December 31, 2026 on substantially the same terms as considered this day. The motion was seconded by Seema Prasad and approved unanimously by the Authority.

Charles Starks and Jasmine Quattlebaum provided a DBE Update (Attachment #1), and there was discussion.

Charles Starks provided an update on the monthly STR, LLC Hotel Statistics, referred the board to their packets for additional monthly statistics including hotel data and tax collections (Attachment #1), and there was discussion.

With no additional business, the Authority unanimously moved to adjourn at 10:14 a.m.
